- 10) <u>Fire department</u>: Presented by Chief Nova, they had 4 calls. EMS really struggling. FD can still use more members, they are struggling to even get enough member for a quorum at meetings. They participated in a 'mock' accident last Friday in Maple, the kids asked lots of question, felt it was beneficial. The annual "Be Somebody" is Saturday May 30<sup>th</sup> in Brule. Golf tournament is set for Saturday and Monday Lakeside hosts the district meeting. FD attended some pipeline training supplied by Enbridge. Starting in May they are going to combine with the Maple FD on the 3<sup>rd</sup> Wednesday of the month for training. Still looking for a washer and a dryer, they are also looking to get the electrical and plumbing ran so they can hook up, as they really need an option to clear their gear. Also needing internet run into the FD office as well as wireless access to the printer, Jon will help with both.
