Working on brushers, grading roads, hauling gravel and future culvert replacements. 2 storms ago some trees came down, they need to be cleaned up, they also removed the 2 big poplar trees in the cemetery removed. Resident is placing rocks on Metraud road that may cause future issues, Tom will reach out to individual. Placed "road closed" sign at the end of Amnicon River road as there is a drop off and if you do not know the area could be a potential problem.
