

Town of Lakeside Regular board meeting

October 13th 2020

Meeting called to order by Chairman Scott Luostari @ 6:30p.m.

COUNTY SUPERVISOR REPORT: Communicable disease committee passed captive cervid ordinance and was sent on to full county board for approval. Moratorium that was in effect will expire in November. Zoning committee will begin work on new zoning district that will address captive cervid farms. County board meeting is October 15th on agenda is captive cervid ordinance and resolution authorizing Douglas County employees to serve as poll workers for November election. Administration and Transportation committees did not meet this month. Scott read highway department update from highway commissioner. Scott also gave information on WISDOT project on Hwy 13. Project to begin in spring of 2022.

TOWN EMPLOYEES/ROADS: Mark reported that repairs on the pavilion that was damaged by heavy snow were completed. Lots of work was done at the cemetery, low area was filled in. Ditching needs to be done on Moonshine road Mark has talked with Amnicon about it. Question on Tammy Ranta's driveway and farm. Each has own fire number and should pay current rate for each one. Guard rail at end of Middle River Road is falling into lake. Mark wants to remove it and put big rocks in its place. New brusher should be delivered this week.

PUBLIC COMMENT: Jerry Moe from Sheriff's Department was present to comment on incidents and calls the department has received in the area. He also answered a couple of questions from concerned residents.

MIDDLE RIVER PROPERTIES: Jane Anklam and Erica Lang from Landmark Conservancy were present. Jane thanked the town for their help with property acquisition and easement. Erica spoke on property opportunities such as simple trails for walking and hiking, and will look for ideas from the town residents also. She also had examples of signage for the area and will asked town for their input.

NEW BUSSINESS:

COLLECTION SITE: Scott talked about the recycling containers and issues of contamination. Waste Management to put lock box on containers and the attendant will unlock them when collection site is open. As of now recycle containers will remain unlocked. Still looking for another collection site attendant for fill in when current attendant is not available.
