# **Department and Committee reports**

10. Fire Department: Tracy-The FD members have been going through training. Tracy, Nova and Martin are 1<sup>st</sup> responders. Mary asked whether the FD wear masks to their medical calls, as members have been seen without them, just concerned for their health with COVID.

11.Town Employees and roads: Mark-talked to the individual's family about the kid tearing up the roads with his 4-wheeler. New culverts were placed without notice on the west section of SVL. Busy grading and brushing. Has had 2 calls on the grader already, people are coming to see it from down state. Grader on the WI surplus site, the board has the right to approve or deny any offers, ends the 21<sup>st</sup>. The board would need to call a special meeting, as most people think if they buy it, they can pick up the next day. The surplus site is a free service for the municipalities. Culvert still needs to be replaced on Camp Road, should take 4-5 hours, need help with the 2 big ones. Trying to grade and haul, rock to get ready for winter, the roads are rough due to the lack of rain. ATVs are not following the 25 MPH speed limits. The sign for the Conservancy property is not in a safe place. Maria done so we have no collection site worker.
