

**Resolution for Electors to Adopt the Town Tax Levy at Special Town Meeting of the Electors**

Whereas s. 60.10(1)(a) of Wis. Statutes authorizes the town electors of a town to adopt the town tax levy at a town meeting of the electors.

Whereas a special town meeting of the electors has been called for this 12<sup>th</sup> day of November 2024.

Now, therefore, the special town meeting of the Town of Lakeside, Douglas County, Wisconsin, by a majority vote of the eligible electors voting on this 12<sup>th</sup> day of November 2024 duly assembled and voting resolves and orders as follows:

BE IT RESOLVED, the town electors of the Town of Lakeside, Douglas County, Wisconsin hereby adopt the town tax levy for 2024 to be collected in 2025 in the amount of \$172,235.

The town clerk shall properly post or publish this resolution as required by law under s. 60.80(1)(a), Wis. Statutes within 30 days of adoption.
