Camp Amnicon rd; looked at culverts at driveways on east side, fire # 3122 and # 3130. Contact will be made to property owners for the replacment of culverts to help with water over roadway at this location. Board to discuss. Culvert by fire # 2457 is 5' diameter and needs replacing as Mark said the bottom is out. Still having beaver dam problems. Looking at placing some 4" rock and cutting back trees on the west Camp Road.

Walsh Road is still closed and the board will see the cost of reopening. Mill Loop/Windmill will have Douglas County Highway Department will be get water from river for Highway UU work.

The board looked at the Hanson Road for possible pulverizing and adding gravel when the countyn was working on Highway UU. Hermanson Road was ok just needs grading.

Engdahl Road was in good shape just needs grading. There was a brief discusion on the town property on the end of the Colby Road. Scott to talk with county surveyer and forestry deptartment for possible harvesting some timber.

22 Road is ok just needs grading. Anderson Road turn around needs some work, Mark is trying to catch the property owners prior to doing anything.

Amnicon River Road to Sage Road needs grading, Barthlamue Road needs to have trees cut back and brush cut as it is rubing against town equipment. Section 6, Joki rd, and Kaarto Rd need grading. Hauwkett Road needs grading and gravel also need to contact Remax on culvert that is does not have permit.

Roads are in good shape after going through the winter, grading and gravel as needed and ditching in needs to contiue. Talked about renting skid steer for shoulder wrok.
